ADMINISTERING MEDICATIONS

We can administer medication for an additional charge of \$3 per day. It is very important that we know when the last dose of medication was given prior to check in. If you have medications to be administered during your pet's stay, please complete our Medication Administration – Instructions & Consent in addition to this form. (Initial) _____

FEEDING

We ask that you provide your own dry food, wet food, and/or treats. Our facility has "house" food available for an additional \$5/night. We do not have wet/puppy food on site but are able to provide two options in the event your pup runs out: 1.) Purina One Chicken and Rice dry dog food, 2.) Hill's Science Diet Adult Sensitive Stomach & Skin Dog Food. When checking your pet in for their stay, please make sure to provide/confirm the feeding instructions in Gingr. HEALTH, MEDICAL TREATMENT AND EMERGENCIES

We will attempt to contact you before non-life-saving medical treatment is instituted by using the primary phone number listed during registration. In the event you are unreachable, we will attempt to communicate with the emergency contact listed. AFTER HOUR CARE FOR BOARDING ANIMALS

Unleashed Retreat is not a 24-hour facility and there will be times when your pet is secure but left unattended. No staff members are on the premises after hours and we do not have a fire sprinkler system in place, but our security cameras are on at all times. (Business hours are as follows: M-F 7a-7p, Sat 9a-5p, Sun 1p-5p.) On Sundays, a kennel technician is scheduled to come in twice, once in the morning and once in the evening to care for boarded animals. During this time your pet will be given meds (*if needed*), their kennel will get cleaned and water will be refreshed. They will also be fed and given an opportunity to exercise and socialize. (Initial) _____

PERSONAL BELONGINGS

Unleashed Retreat does not replace lost or damaged items that are checked in with the pet as their personal property. Under all circumstances, Unleashed Retreat is not responsible for lost or damaged items left with the pet, including but not limited to leashes, beds, blankets, toys, etc. (Initial) _____

ACCIDENTAL DAMAGE OR INJURY

Pets may be unpredictable, especially in an unfamiliar environment with new friends. Please understand that there are inherent risks in working with and caring for pets. Accidents or injuries due to events including but not limited to rough play, fights, or escape from enclosure may occur. Pets are always given separate kennels for their safety. Should you request for your pets to be boarded together and an accident involving your pets does occur, after or during business hours, we will notify you as soon as possible and by signing this document you are acknowledging the potential risks in boarding them in the same space and agreeing to all financial responsibility that may result.
